UL President and CEO to Keynote The Monitoring Association's 2021 Annual Meeting

August 23, 2021, McLean, VA – The opening keynote for The Monitoring Association's (TMA) 2021 Annual Meeting is Ms. Jennifer F. Scanlon, president and CEO, UL Inc. In her session, Collaboration—Our Force Multiplier for Forging a Profitable Future, Ms. Scanlon will address the megatrends that are reshaping the alarm and monitoring industry.
